

Survey Results 2018 - Dairy Health Surveillance Network

- 1) Ranking of Action Items (most important -> least important, based on weighted average responses)
 - 1. Decide what questions we'd like to answer through surveillance
 - a. (Eg. Disease freedom, production limiting disease, antimicrobial usage, etc.)
 - 2. Develop a comprehensive stakeholder engagement map.
 - a. Map relationships and ensure linkages identified from provincial/regional level to the national level.
 - 3. Develop/use the CAHSS website for intelligence sharing disease alerts, reports, emails
 - 4. Define the value proposition for all stakeholders
 - a. Needs, benefits of a national surveillance network for stakeholders
 - 5. Identify a Champion in each province to contribute to the national surveillance network group.
 - 6. Develop a process to facilitate ongoing surveillance using bulk milk tank samples, providing feedback and benchmarking for participating producers.
 - Develop a national information sharing platform, similar to RAIZO, OAHN, CSHIN, and hold quarterly conference calls.
 - 8. Data mining and integration understand, find, collect and integrate data from multiple sources, then determine gaps.

Comments:

- AMU surveillance questions should be specific to advancing AMS by dairy vets and on dairy farms
- Statements are unclear and dependent on certain variables
 - o For example:
 - Should there be a champion for each province?
 - Yes there should be a point person but the value depends on whether or not that person is connected and informed. If they are appointed by gov't and not connected within the commodity group it will "kill" the network.



2) Additional Action Items to Bring Forward

- Perception that there are several initiatives that could benefit from synergism
- Something else is needed to entice primary producers and/or practicing veterinarians,
 otherwise the surveillance will be only superficial and short lived
 - o There are many kinds of projects that could be developed if funding is available
- 3) Satisfied with progress of the Dairy Group Network activities?
 - Current pace is good, don't reduce frequency of calls
 - Probably need to form more active project groups on a series of useful surveillance projects with funding to keep things from moving too slowly
















